Consistent Control and Management of SOPs in a Regulated Environment

Challenges

The nuclear power industry is a highly regulated environment and requires strict adherence and consistent use of standard operating procedures (SOPs) to ensure safe and continuous operation. Effective management of these critical business documents are essential to the organization. The client recognized that it needed a simple, but powerful solution for managing the creation and revision of SOPs.

Solution

The procedures management solution was the company's first solution implemented with the Intellidox® framework. The solution provided the client with a full revision control process that consistently manages procedures throughout their lifecycle.

Smart Automation

At inception, each new procedure, or revision, is automatically named and filed based on its functional topic and level of use. As a procedure transitions from one lifecycle state to another, the solution controls the document's location and security, creates a watermarked PDF copy, and notifies key groups for review. The solution automatically performs an up-rev process for approved revisions, ensuring that all users are accessing the latest, approved revision.

The solution provided a number of automated notification and reports. On a nightly basis, an email notification containing the list of all newly issued procedures and revisions is distributed to all department manag-

ers. Another automated notification is distributed to the Procedures Supervisor whenever a procedure is due for periodic review. Additionally, supervisors have access to several pre-built reports, including a Procedures Aging Report that captures the duration each procedure has spent in a particular state prior to issuance.

Smart Control

The Intellidox platform provides the client with an amazing degree of control and flexibility with its Procedures Management Solution. The majority of business rules enforced by the system, such as naming, filing and the lifecycle, are completely configurable by an administrator. The Intellidox Name Resolution™ (INR) engine provides an extremely powerful meta-language tool for dynamically resolving values and paths at runtime.

The Intellidox solution leverages the built-in Documentum security model and extends it further to provide additional security and access control for key application functions. Administrators can readily configure security for the following:

- who can create new procedures;
- who can promote from one state to another;
- who can initiate new revisions; and,
- who can complete a revision (execute an up-rev).


